Dear Lakes at Northpointe Residents:

Come and join in on some fun in the sun and swimming at the Lakes at Northpointe Recreation Center! As the summer continues to heat up, please enjoy the recreation center for some great summer fun. In order to qualify for pool registration, you must be a resident of Lakes at NorthPointe, and your account must either be paid in full, or your payment plan must be 60% paid.

Enclosed you will find information regarding pool registration and the hours of operation for the Summer of 2023. You are required to have a pool wristband on your person to be able to access the pool area. You must be present within the fenced area of the pool with any children thirteen (13) years of age and under as well as when you bring guests. You will not have access to the pool when it is closed and there is no lifeguard on duty. There is no charge to pick up pool wristbands if they are picked up during the scheduled pick-up days at the pool. You must register for wristbands by email, prior to picking up your wristbands:

GUEST POLICY: The guest policy is as follows:

Two guests per pool wristband issued, <u>not to exceed six guests per family</u>, whichever is greater. There will be no guest fee for the 2023 summer season. Guests are permitted with a resident 18 years or older. Minors with guests must have a parent present at all times.

POOL REGISTRATION AND VALIDATION INFORMATION

Eligibility requires that you are an owner and/or resident of Lakes at Northpointe Community Association to obtain your pool wristbands. To avoid use of the facility by ineligible people, access to the pool WILL BE DENIED without the proper pool wristbands. This is for the protection of the residents and owners of the Lakes at Northpointe and your assistance in bringing your pool wristbands will assure only eligible people are using the facilities. If you are a renter or you are not listed as the owner and are over the age of 21 you will need to show proof of residency.

Please complete the enclosed registration form. If you are a renter, you should enclose a copy of your driver's license or a utility bill as proof that you are a resident.

THERE ARE TWO WAYS TO GET YOUR WRISTBANDS

submitted, you will be able to pick up your pool wrist bands at the Lakes at Northpointe pool during
the registration dates listed above. Children under the age of 14 are not permitted access to the
pool without an adult and will not be issued pool wristbands. All person's age 14 and over will be
required to have a pool wristband. In order to qualify for pool registration, you must be a resident of Lakes
at NorthPointe, and your account must either be paid in full, or your payment plan must be 60% paid. There is
no charge to pick up pool wristbands if they are picked up during the scheduled pick-up
days at the pool.

You must Register prior to picking up your wrist bands!

2. AFTER, MAY 13TH, POOL WRISTBANDS WILL BE AVAILABLE AT Chaparral Management Company at 6630 Cypresswood Dr. Spring, TX 77379. Pool wristbands distribution will close at 4:00 pm Monday thru Thursday and on Noon on Friday. Please bring your completed registration form. There will be a charge of \$5.00 per wristband, payable by CASH ONLY, when purchased at the Chaparral Management office.

LAKES AT NORTHPOINTE HOMEOWNER ASSOCIATION POOL RULES

- 1. The pool area is private property and for the exclusive use of registered residents and their guests.
- 2. Pool tags/bands are required for entry into the facility.
- 3. Two guests per pool wristband issued, not to exceed six guests per family. Members must be present in the pool area when the have guests present. Minors with guests must have a parent present at all times.
- 4. Members will be held responsible for the actions of their guest(s) at all times.
- 5. All persons using the pool or pool area do so at their own risk and sole responsibility.
- 6. Swimming is allowed only when a lifeguard is on duty.
- 7. Children under 14 years of age must be accompanied at all times by an individual 18 years of age or older to be admitted to the pool area.
- 8. All non-toilet trained babies must wear swim diapers.
- 9. The wading pool is limited to children under the age of 6 years old. Parents are responsible for the supervision of their children at all times.
- 10. Only Coast Guard-approved life preservers are permitted and the supervising adult must be within arms-reach of the child wearing the life preserver.
- 11. No diving in the areas 6 feet deep or less per Texas code.
- 12. Alcohol and other drugs are prohibited.
- 13. Smoking in prohibited inside the pool area.
- 14. Loud music is not permitted around the pool area.
- 15. Profanity, vulgarity, improper behavior and intoxication are not allowed.
- 16. No running, pushing, rough play, wrestling, ball playing, dunking, splashing, or causing undue disturbances in or about the pool area.
- 17. Appropriate swimwear must be worn in the pool. No cut-off jeans or pants, shorts or tennis pants. Only shirts can be worn as protection from the sun in the water. UV swimwear is permitted.
- 18. A "Safety Break" will be called for 10 minutes every hour by the lifeguard. During this period, only adults aged 18 and over will be permitted to stay in the pools.
- 19. The pool may be closed or its use limited at any time because of weather, operational difficulties, overcrowding and at the discretion of the manager. In case of lightning or thunder, Red Cross current standards will be used.
- 20. For the safety and enjoyment of all, the lifeguards have full authority to ask unruly guests to leave the facility.
- 21. Management will not be held responsible for the loss or damages of any personal property of any kind.
- 22. DO NOT SWIM IF YOU HAVE BEEN ILL WITH DIARRHEA OR A COMMUNICABLE DISEASE WITHIN THE PAST 2 WEEKS
- 23. PETS IN THE POOL ARE PROHIBITED
- 24. NON-SERVICE ANIMALS PROHIBITED
- 25. CHANGING DIAPERS WITHIN 6 FEET OF THE POOL IS PROHIBITED
- 26. GLASS ITEMS NOT ALLOWED IN THE POOL YARD
- 27. PERSONS UNDER THE AGE OF 14 MUST NOT BE IN THE POOL WITHOUT ADULT SUPERVISION
- 28. EXTENDED BREATH HOLDING ACTIVITIES ARE DANGEROUS AND PROHIBITED
